





# "SAN FRANCISCO SALAD"

(serves 6)

 Ib. fresh Crab Meat or cooked and shelled small Shrimp (We use medium shrimp, chopped.)
cups diced celery
Tbl. minced green onion
to 1 cup mayonnaise
large tomatoes, sliced thickly
large cooked artichoke bottoms
head Iceberg lettuce, shredded
hard-cooked eggs, finely chopped

#### Directions:


In a large bowl, combine the crab meat or cooked shrimp, celery and onion. Add just enough mayonnaise to bind the ingredients together. Set aside.

On each plate, place a thick slice of tomato and put an artichoke bottom on top. Then add a mound of the crab or shrimp mixture on top. Circle each mound with some shredded lettuce and garnish with chopped egg. Serve with the following "Louis Dressing."

### "LOUIS DRESSING"

#### Whip together:

2 cups mayonnaise 1/2 cup heavy cream 1/2 cup chili sauce <sup>1</sup>⁄<sub>4</sub> cup chopped onion salt and pepper to taste 1 Tbl. lemon juice
